

# Wahl Dirty Dogs Photo Contest 2014

## RULES AND REGULATIONS

### A PURCHASE IS NOT NECESSARY TO ENTER THIS CONTEST

#### DATES OF CONTEST:

Contest opens on June 16, 2014 at

12:00 a.m. Central Standard Time (CST) and closes on July 31, 2014 at 11:59 p.m. CST (the "Contest Period"). The submission period will begin on June 16, 2014 at 12:00 a.m. Pacific Time and

Contestants must submit all entries no later than 11:59 p.m. on July 12, 2014.

#### ELIGIBILITY:

This Contest is intended for residents of the United States of America only, and by entering you agree that this Contest will be subject to and governed by the laws of Illinois, excluding all conflict of law rules, and the forum for any dispute will be in Illinois in the City of Chicago. This Contest is being conducted by HYConnect ("HYC"), and excludes employees and personal associates, families, as well as those with whom they reside, of HYC, directors, officers, representatives and agents of HYC, and Wahl, GreaterGood.org or The Animal Rescue Site (hereinafter referred to as the "Sponsors"). All entrants and winners must be 18 years of age or older.

(2) Registration: Complete the official Contest online entry form (the "Entry Form") in its entirety including: first name, last name, pets' name, and contact information. You must submit a before and after photo of the same pet.

Entries will be rejected if the required fields of the entry form (labeled with \*) are not fully completed and submitted during the Contest Period. Use of any automated system to enter is prohibited and will automatically result in disqualification.

There is no limit on entries during the submission period.

Sponsor and Contest Entities are not responsible for lost, late, mutilated, incomplete Submissions. All Submissions (including all intellectual property rights embodied therein) shall become the exclusive property of the Sponsor and will not be returned.
